FDA- PSN Update:

Diane Ducharme (FDA-PSN)

- Produce Safety Network should have a representative from FDA to work with on the PSR. Trevor is the other one in the SC. Latin American office personnel have been added.
- Proposed Ag water rule- December the Proposed Ag Water rule came out, Supplemental notice released in July that is currently open to comment. The Ag Water Builder online tool is being worked on as well.
 - <u>Discussion</u>: 9 months turn around- Updating PSA Slides, Updating PSA information, updating grower and regulatory education. Rene, TDA- also concerned about the turn around and time to educate. Diane- the education is paramount before complying and FDA "recognizes it." Betsy- concerned about where water occurs in the curriculum. When the new subpart E drops, the PSA Team will have to drop everything to update everything, will have to launch train-the-trainer, will have to wait on FDA wait to review everything. The tool will need to be practiced on the farm with groups of growers Michelle it is going to take time; 9 months is too soon.

Dianne- we need to consider the regulators needing trained to. Have until September 17th to comment.

Cyclospora- task force and fact sheet updated on the FDA website.

- Mariana- based out of California, new PSA Spanish associate.
- Collins Bugingo- NW associate
- SW associate position is closed, and candidate has been selected, waiting on approval from Cornell.
- 8,861 in person grower participants and 2,419 remote participants
- 115 growers in Southern Region have taken the online course.
- Policy updates:
 - Remote training policy is temporary. In-order to make permanent, they must evaluate the evaluations.
 - October 1st, 2021- instituted a grower training prerequisite for taking the TTT.
 - Spanish language group is taking off. We need grower trainings in Spanish and then a TTT in Spanish.
 - Alternate Delivery Policy- access to training for languages that are not available in PSA or cannot read.
- Held one in June 2022- planning one in February 2023. Trying to figure out how to get more trainers to the training

- Subpart E office hours- Thank you to the SC for donating your time to be involved. Focus groups submitted on grower behalf.

- TDA, Rene- more people asking questions about on-farm application. TDA is taking training out of CAP grant. Offering trainings for Spanish, Small producers, and exempt growers
